1. All CESCO products (Product) have one year period of guarantee from the date of Delivery. This warranty only applies in the countries/areas covered in the agreement between CESCO Bioengineering Co., Ltd. (CESCO) and her distributors/dealers.
2. Within the period of guarantee, CESCO shall take the responsibility for repairing Product for free due to the design and manufacture flaws. CESCO her distributors/dealers shall, according to the signed agreement, replace defective Product directly or defective parts with new or validated parts. All replaced Products and parts belong to CESCO.
3. The range of the warranty does not cover followings including: (1) Force Majeure events such as act of God, war, strike, riot, crime, etc; (2) The power supply to any part of Product exceeds the rated tolerance; (3) Improper storage or exposure to acid, basic, humid, abnormally corrosive environment, or at extreme temperature; (4) Unauthorized modification, test, upgrade, repair, addition of parts in Product; (5) Unauthorized internet connection or program modification to Product; (6) Misuse, negligence, abuse, accidental loss, and intended damage; (7) From the use of Product in a manner that is not controllable or reasonable to CESCO.
4. Product case and its accessories and parts should be with insurance during the shipment, and thus are not covered in this warranty.
5. This warranty does not cover the consumables, gifts, bonus those accompany with Product in the same purchase order.
6. If this warranty expires, the customer shall afford all part fee, shipping fee, insurance, labor fee, and other related cost of Product. CESCO has the right to refuse the customer and to suspend, delay, and cancel the request thereof if he/she disagrees the quotation or items of the service.
