Placed below is a Quotation dtd 4-4-2022 from M/s Mahavir Auto Diagnostics Pvt Ltd towards cost of a Skoda Superb L&K AT Model. It can be seen that while the Ex-Showroom Value of the Car stands at Rs.35,53,370/-, computed together with the Life Tax, TCS, Regular Insurance etc. the total cost works to **Rs.43,22,506/-**.
